Pool: 2009 pool rates have been recommended by the committee. Single membership \$110.00. Each additional same family membership \$55.00. Day Care Providers rates are 2 adults and 6 children ages 6 or younger \$175.00. Over 6 years of age must pay or have pass. Supervisor must pay if getting into the water. Pool parties are \$70.00 per hour. Daily admissions for adults is \$5.50, students (17 and under) \$4.50 and senior citizens \$5.00. Children age 4 and under admitted free with paying adult. 12 day pass for student is \$35.00 and adult \$45.00. There is a 10% discount for passes purchased at the pool from June 6th – June 13th. The pool will open June 6th through August 21st. Regular hours are Monday – Saturday 11-6 and Sunday 12 – 6. Lusk made a motion to accept the 2009 pool rates recommended by the pool committee. Motion seconded by Maurer. (RC 5 yes)

At 7:40pm, Loos made a motion to move into executive session to discuss village personnel issues. Motion seconded by Rogers. (RC 5 yes)


At 8:22pm, Lusk made a motion to continue in regular session. Motion seconded by Loos. (RC 5 yes)
