## 2009 West Lafayette Income Tax Return Instructions

- Line 1 --- Residents include income from all W2s whether you worked in the village or outside the village.  
 Non residents include only the income earned while you worked within the village.
- Line 2 --- Other income--1099 misc., commission, etc. Do not include unemployment, pensions, SS, interest, or dividends.
- Line 3 --- Total of Lines 1 and 2.
- Line 4 --- Net income from businesses located in the village or net income derived from doing business in the village but not located in the village. Carry over losses are not permitted.
- Line 5 --- Income from rental property located within the village.
- Line 6 --- Income that does not fit the above categories include supporting documents and an explanation of the source.
- Line 7 --- Total of lines 4, 5, and 6. If less than zero then enter "0".
- Line 8 --- Total Taxable income--add lines 3 and 7.
- Line 9 --- Calculate tax due by multiplying line 8 by 1% (0.01).
- Line 10 -- Total West Lafayette tax withheld by your employer(s) from all W2s.
- Line 11 -- Total tax withheld for other municipalities. Credit given for a maximum of 1% (0.01) of taxable wages from W2s.
- Line 12 -- Total of prepayments made during 2009 for 2009 tax liability.
- Line 13 -- Refunds from previous years that were applied to future tax years.
- Line 14 -- Total of lines 10, 11, 12, and 13.
- Line 15 -- TAX DUE--If line 9 is greater than line 14 then subtract line 14 from line 9 to calculate tax due.
- Line 16 -- TAX REFUND--If line 14 is greater than line 9 then subtract line 9 from line 14 to calculate the excess taxes paid or withheld.
- Line 17 -- Enter the amount you want to apply to next years taxes in lieu of a cash refund.
- Line 18 -- Penalty for late filing. Multiply line 15 by 1 and 1/2% (.015) to calculate the penalty charge. Minimum charge is \$10.00.
- Line 19 -- Interest charge for late filing when taxes are due. Multiply line 15 by 1/2% (.005) times the number of months past due.  
 Example: File in July - 1/2% (.005) times tax due (line 15) times 3 months (May, June, July).
- Line 20 -- Total due for late filing add line 15, 18, and 19.
