Village Personnel:

 Mayor Patterson informed Council that Fiscal Officer Roberta Moore was resigning and her last day with the Village would be February 27th, 2015.

 Mayor Patterson informed Council that Roberta has offered to continue doing payroll and pay bill until mid-April. The proposed rate of pay is \$20 per hour with a

minimum of five hours per week.

Mayor Patterson indicated Roberta would not have time for preparing the agendas for council meetings or doing the minutes. Christie Maurer volunteered to keep the minutes with the Village Administrator typing them up for review.

Mayor Patterson reestablished the hiring committee of Maurer, Warne, and

Bordenkircher.
