VA received notification from OEPA that they will be reclassifying the Village's Waste Water Treatment Plant to a Class I from a Class II. Tye Twarog along with other employees has requested to be able to take vacation days in half day increments. After little discussion, council agreed and felt that would be fine. VA will make necessary changes to wage/benefit ordinance for council's approval next scheduled council meeting. However, Tye is requesting to take off July 31st ½ day vacation. Council all agreed that he may take this day off. Rogers made a motion to allow emoployees to

take ½ day vacation days. Motion seconded by Loos. (RC 6 yes) Allowing people to hunt and drive personal vehicles on village property has become an issue. All council members agree that absolutely no hunting or driving personal vehicles should be permitted on village property due to liability reasons.
