Whereas, the Ohio Public Works Commission has informed the Village only a 7 year term can be offered on the loan and not a 10 year term as originally anticipated,

NOW THEREFORE, BE IT RESOLVED BY the **VILLAGE OF WEST LAFAYETTE COUNCIL**:

Section 1: That Resolution 2013-32 is hereby repealed,


Section 2: That the Fiscal Officer is hereby authorized and directed to Certify Funds availability for the **Alley Paving Program 2014**.


Section 3: That the Mayor is hereby authorized to enter into any agreements as may be necessary and appropriate for obtaining this financial assistance.


