Whereas, the State Capital Improvement Program and the Local Transportation Improvement Program both provide financial assistance to political subdivisions for capital improvements to public infrastructure, and

Whereas, the **Village of West Lafayette and County Engineer** are planning to make capital improvements known as **County Resurfacing Program 2015**, and


Whereas, the infrastructure improvement herein above described is considered to be a priority need for the community and is a qualified project under OPWC programs,

NOW THEREFORE, BE IT RESOLVED BY the **VILLAGE OF WEST LAFAYETTE COUNCIL**:

Section 1: That the Fiscal Officer is hereby authorized and directed to Certify Funds availability for the **Round 29 Village of West Lafayette County Resurfacing Program 2015**.

Section 2: That this resolution shall be and is hereby declared to be an emergency measure for reason that the Village needs to apply needs to submit the application by October 31st, 2014, and for reason thereof this resolution shall be effective immediately upon passage, signing by the Mayor, and posting.

Subject: OPWC Project Review

To: Village Council

Council:

An update on the seven projects send to the Local OPWC Committee for funding by OPWC Rounding 29 (Issue II).

Project 1: Resurfacing Oak Street with asphalt from Main Street to Union Avenue. This would consist of approximately 520 linear feet with a width of 38 feet plus 145 linear feet with a width of 43 feet for a total of 2890 sq. yds. The estimated cost for this work is \$30,600 with the Village being responsible for 50% of the cost.

Update: Project 1 approved by the local committee and will be sent to the district for final approval.

Project 2: Resurfacing Fifth Street with asphalt from Oak Street to Center Street. This would consist of approximately 760 linear feet with a width of 22 feet plus 360 linear feet with a width of 39 feet for a total of 3420 sq. yds. The estimated project cost is \$31,500 with the Village being responsible for 50% of the cost.

Update: Project 2 approved by the local committee and will be sent to the district for final approval.

Project 3: Resurfacing Kirk Street with asphalt from Railroad Street to Main Street. This would consist of approximately 285 linear feet with a width of 22 feet for a total of 700 sq. yds. The estimated project cost is \$10,600 with the Village being responsible for 50% of the cost

Update: Project 3 was approved by the local committee and will be sent to the district for final approval.

Project 4: Resurfacing Oak Street with asphalt from Fifth Street heading south until the dead-end is reached. This would consist of approximately 309 linear feet with a width of 37 for a total of 930 sq. yds. The estimated project cost is \$10,500.

Update: Project 4 was not approved by the local committee. If the work is to be done, it must be funded 100% by the Village. Not part of the grant application.

Project 5: Resurfacing Seventh Street with asphalt from King Street to Gay Street. This would consist of approximately 500 linear feet with a width of 20 for a total of 1110sq. yds. The estimated project cost is \$10,900

Update: Project 5 was not approved by the local committee. If the work is to be done, it must be funded 100% by the Village. Not part of the grant application.

Project 6: Resurfacing Seventh Street with asphalt from Oak Street heading west until the dead-end is reached. This would consist of approximately 226 linear feet with a width of 26 for a total of 655 sq. yds. The estimated project cost is \$6,600

Update: Project 6 was not approved by the local committee. If the work is to be done, it must be funded 100% by the Village. Not part of the grant application.

Project 7: Resurfacing Indian Circle with asphalt from Seventh Street heading south until the dead-end is reached. This would consist of approximately 196 linear feet with a width of 24 for a total of 525 sq. yds. The estimated project cost is \$5,400

Update: Project 7 was not approved by the local committee. If the work is to be done, it must be funded 100% by the Village. Not part of the grant application.

The total cost for the three approved projects is \$72,700 with the Village's share being estimated at \$36,500
