ORDINANCE TO HIRE A SOLICITOR FOR THE YEAR 2016 & 2017

BE IT ORDAINED by the Council of the Village of West Lafayette, State of Ohio:

SECTION I. That William M. Owens be and hereby is appointed solicitor for the Village of West Lafayette, Ohio, for the period commencing January 1, 2016 and ending December 31, 2017, at a contract amount of One Thousand and 00/100 (\$1,000.00) Dollars per month, plus reimbursement for all out of pocket expenses, including but not limited to mileage at the rate permitted by the IRS. William M. Owens will be paid monthly amounts of One Thousand and 00/100 (\$1,000.00) Dollars each, on the Fiscal Officer's first pay period of the month, through December, 2017. William M. Owens is not an employee of the Village of West Lafayette. He shall receive no benefits; including but not limited to, Public Employee's Retirement. He will receive reimbursement not to exceed Five Hundred and 00/100 (\$500.00) Dollars yearly for tuition for Municipal Attorney Association Seminars, meals, and lodging.

SECTION II. That with prior consent of council said solicitor shall be and hereby is authorized to retain such other attorneys, including attorneys not members of his office, in situations and cases involving scheduling conflicts, vacations, and conflicts of interest; said attorneys shall be retained on such terms as Village Council authorizes, and in addition, with prior consent, said solicitor shall be and hereby is authorized to hire investigators, title searchers, surveyors, and such other professionals and assistants as may be necessary, attend continuing legal education conferences, join municipal law organizations on behalf of the Village of West Lafayette, Ohio, and to bill the cost thereof to the Village of West Lafayette, Ohio. Either party may terminate this agreement without cause upon sixty (60) days notice to the other party.


SECTION III. That this ordinance shall be effective at the earliest date provided by law. William M. Owens shall make appearances in Coshocton Municipal Court for the Prosecution of Village Ordinances commencing upon passage of this ordinance. William M. Owens shall perform legal counsel services for appeals in state courts from Municipal Court excepting pending appeals. William M. Owens will also not be required to make appearances in Federal Court, Bankruptcy Court, represent the Village in matters with Federal agencies or pertaining to federal law, employment law, or represent council in bond counsel matters, for reason he does not practice in these areas. In addition to the foregoing, in the event that William M. Owens performs legal services for the Village of West Lafayette, Ohio in excess of ten (10) hours per month he will be paid an additional sum of One Hundred and Fifty and 00/100 (\$150.00) Dollars per hour for all work performed in addition to the One Thousand and 00/100 (\$1,000.00) Dollars per month.


