Fire: Chairman Lusk reported 13 runs for December. Lisa has received the signed fire contracts from Lafayette, Oxford, White Eyes, and Linton Townships. Mayor and Fiscal Officer also signed contracts. All four township contracts have now been signed and received for 2012. Lisa has made copies and returned them to the townships for their files and copies to Fire Chief Hill. Chief Gaylord Hill reported to Mayor and Council that he has been talking to the four townships about putting a ½ mill capital outlay levy on the ballot this fall. He also mentioned about all of the unfunded mandates that the department is trying to comply to with the current budget. Chief reported that the department has received quotes and plan on proceeding with the next step in constructing the addition to the current fire department building. Captain Damon-Gould-gave the annual fire report. During 2011, the department responded to 147 calls. The department currently has 18 members, which consist of 1 Chief, 1 Assistant Chief, 5 Captains, 3 Lieutenants, and 8 Firefighters.
