West Lafayette Village Council met in regular session at 7:00 P.M., in the municipal building with Mayor Jack L. Patterson presiding.

Pledge of Allegiance

Roll Call: Dave Rogers, Roger Warne, Kelly Gossett, Ron Lusk, Christie Maurer and Dean Wears were present.

Reports:

Village Administrator: VA was pleased to announce that the village has been awarded \$250,000 grant money through Appalachian Regional Commission (ARC). We were also awarded the grant forgiveness, but unfortunately, the program was out of money. However, if another awarded entity is unable to proceed with their project, we are on the list to receive any unused monies available. VA reported that they will be flushing hydrants weeks of May 16th and 23rd. The zoning board of appeals met last Wednesday. VA also reported that the roof at the water plant needs immediate attention. The roof has damage from excessive moisture from the air stripping towers. This has also been discussed with the finance meeting. He will get a couple estimates to replace the roof. The street department will begin working on fixing potholes and grading alleys soon.GGC finalizing the project design and should be ready to go out for bids within 30

days. VA is expecting that the total project cost will be realistically around 1.6 million dollars. As of now, the Village has secured 1 million dollars in true grants and has been approved for a 0% loan through Ohio Public Works Commission (OPWC) for \$666,991
