West Lafayette Village Council met in regular session at 7:00 P.M., in the municipal building with Mayor Jack L. Patterson presiding.

Mayor's Correspondence – Mayor reported several beneficial topics discussed at the Mayor's Conference last week such as: Ethics, conflict of interest, public records, economic development and most interesting was preparing for the healthcare reform. Also, Mike Fitch from ODOT was at the conference.

Citizens' comments –Gary Loos was present asking about mosquito spraying. He wanted to know how often the village was spraying to kill mosquitoes. VA informed Loos that we are spraying every two weeks just like last year.

Doug Hothem expressed his concerns regarding certain vehicles in town sitting along village streets on blocks.

Introduction to ordinances and resolutions:

2010-21 AN ORDINANCE ESTABLISHING A PERMIT TO SOLICIT BUSINESS INSIDE THE VILLAGE OF WEST LAFAYETTE

The second reading was given after discussion about the registration process. In the original Ordinance with the first reading, the applicant must have no felony violations or misdemeanors involving fraud or moral turpitude within the past five years. All members of council agreed that this should be changed to ten years. Concerns with recent applicants, council decided it would be in the best interest of the village residents to pass this ordinance tonight as an emergency. Lusk made a motion to suspend the rules for Ordinance 2010-21 changing five years to ten years and declaring this ordinance an emergency. Motion seconded by Wears. (RC 6 yes) Rogers made a motion to adopt Ordinance 2010-21 as amended. Motion seconded by Lusk. (RC 6 yes)

VA says the Village's cost for the Oak Street paving project will be \$24,000 – \$30,000. After much discussion, Lusk made a motion to commit to paving project this year. Motion seconded by Rogers. (RC 6 yes) Council agreed this needs to be looked at closely next year during the budgeting process.
