Reports:

Village Administrator: VA reported that we have received the 2 new F-550 dump trucks. The trucks were available for all councilmen, Mayor, and news media to look at. Both trucks came equipped with a snow plow and one equipped with salt bin and spreader. VA asked for council's approval to advertise to sell the 2001 Yellow GMC C6500 Dump Truck and the 1993 F-150 pick-up truck. Rogers made a motion to authorize the Village Administrator, Dave Kadri, to advertise and accept bids for these two trucks. Motion seconded by Maurer. (RC 6 yes) VA also reported that four of the five lights in the park are working. There is a wiring issue with one of the lights and it will be addressed as soon as possible. The new lights do not cost anymore to operate; however they are definitely brighter and more efficient. VA reported that he is still waiting on a quote to fix the traffic light at Main and Oak Street. VA says he has heard pros and cons of leaving this intersection a 4 way stop and not replacing the light. The street committee may review this option at a later date if necessary. After receiving notification from the Department of Liquor, VA has investigated a future drive thru at 120 West Main Street owned by David Tatro that will sell alcohol.

Police: Chief Mardis proudly introduced Mr. Daniel Baird to Council and Mayor. Chief is recommending to Council to have Baird on the department as a reserve patrolman. Baird is from the Coshocton area. Lusk made a motion to accept Chief Mardis's recommendation to have Daniel Baird join the department as a reserve patrolman. Motion seconded by Warne. (RC 6 yes)
