They will look at the floor of the pool, the walls and the deck. They will provide the village with enough information to make an intelligent decision between repair, replacement or abandonment. This firm will take information that Patterson Companies gathered in December 2009. The fee for MKC Associates, Inc. to perform this investigation will be \$6,800. Chairman Rogers said this has been discussed in the finance committee meeting and the committee recommends transferring this money from the General Fund to the Swimming Pool Fund. Lisa will prepare resolutions for next council meeting to transfer the funds and to appropriate the money.
