Department Reports:

Fire: Ohio adopted the International Fire Code in 2011. There are some conflicting items between the International Fire Code, the Village Zoning, and the Village Ordinances regarding fire. Chief Hill requested consideration to void ordinances and zoning as pertains to fire allowing him the ability to enforce the codes set forth by the State.
