West Lafayette Village Council met in regular session on February 11, 2013 at 7:00 P.M., in the municipal building with Mayor Jack L. Patterson presiding.

Mayor's Correspondence -N/A

Citizens' comments – Doug Hothem was expressing concerns of the possibility of losing our local Police Department. Along with Doug's appearance came many phone calls today regarding this same issue. The Mayor assured him and several others that the article in the Coshocton Tribune was referring to the Village of Frazeysburg giving a second reading to abolish their Police Department not West Lafayette. The Mayor and Council have no intentions of eliminating our Police Department. Chief Mardis thanked all for the genuine concerns and comments.

Lawrence Schlegel talked about the building at 100 West Main Street. He had questions and concerns regarding the historical value of this structure. He may revisit council again with more information regarding his purpose.

Reports:

Village Administrator: VA is asking for approval to give River Glenn Estates a credit on the sewer part of their utility bill. A few weeks ago there was a water break with about 250,000 gallons of water going onto the ground. Owner, Bob Nelson, is willing to pay the water consumption however, he is asking for a credit for the sewer portion of the invoice. Since the water didn't go thru the village's sewer system. Dave is in agreement with giving a credit if council agrees. The credit will amount to \$1,958.48. After discussion, Rogers made a motion to approve the sewer credit of \$1.958.48 for River Glenn Estates. Motion seconded by Lusk. (RC 6 yes) VA informed the Mayor and Council that Coshocton County Commissioners will be awarding the Village \$2,500 to be used for the Village's parks. VA reported that there was a small water break at 114 W Platt. This was repaired in just a few hours. Councilman Lusk asks VA the status on the traffic light repair at Oak and Main. Dave said he will try to get this addressed when we get a couple of sunny days for everything to dry out. He thinks there is some damage with the wires. Ron asked if the control box at Kirk and Main could operate the light at Oak and Main and also the light at Russell and Oak. Dave said he wasn't sure but he will look into this option and report back.
