A RESOLUTION TO AUTHORIZE AND DIRECT VILLAGE ADMINISTRATION TO ADVERTISE FOR BIDS FOR SALE OF FIRE TRUCK.

Whereas Council for the Village of West Lafayette, Ohio is desirous of selling a used fire truck, now therefore it is resolved:

Whereas Council has reviewed the petition in open meeting and intends to make a decision; Now therefore be it Resolved as follows:


Section One: Council for the Village of West Lafayette, Ohio declares that it is the owner of a motor vehicle known as a fire truck and that it is no longer needed for public use.

Section Two: Council for the Village of West Lafayette, Ohio authorizes and directs the Village Administrator to advertise for invitation for bids for sale of the used motor vehicle namely, fire truck and the year, make, and model number is 1996 FRATE 70.


Section Three: Specification for the invitation to bid and newspaper publication is attached as Exhibit "1" and is incorporated herein as though fully rewritten. The estimated value exceeds One Thousand and 00/100 Dollars (\$1,000.00) and a minimum bid shall be required of no less than Ten Thousand and 00/100 Dollars (\$10,000.00). As per Ohio revised code Section 721.15 (a) the advertisement shall be published for not less than two (2) consecutive weeks in a local newspaper of general publication. The Village shall reserve the right to reject any and all bids and the bid for sale if awarded, shall be awarded to the highest and best bidder.

Section Four: That this Resolution shall be declared an emergency for necessity of health, safety and welfare of the citizens of West Lafayette, Ohio and shall be effective upon passage and signing by the Mayor.





Newspaper Advertisement

Pursuant to Resolution # 2017-31 the Village of West Lafayette, Ohio is offering for sale to the highest and best bidder a used motor vehicle; namely, fire truck make ¹⁹⁹⁶ FREIGHTLINER, model TANKER F70, and serial number 1FV6HFAAITZ8677. The vehicle may be viewed at the Village of West Lafayette, Ohio firehouse ⁸³ daily from 7 o'clock a.m. until 5 o'clock p.m. Complete specifications are on file at the Village Office, 113 East Railroad Street, West Lafayette, Ohio 43845. The vehicle is being sold as is, where is, and without warranty. The successful bidder shall be responsible for delivery. The minimum bid which may be submitted is Ten Thousand and 00/100 Dollars (\$10,000.00). The bid shall be accompanied by a ten (10%) percent certified bank check down payment which shall be returned to unsuccessful bidders. The Village reserves the right to reject any or all bids. The successful bidder shall pay to the Village the remaining amount due by certified bank check and shall take possession of the vehicle and remove it, each within thirty (30) days of award of the bid. Bids shall be opened the 14th day of AUGUST, 2017 during Council Meeting which commences at 7:00 p.m. and the purchase and sale or rejection of any or all bids shall be announced. A contract of sale shall be executed within seven (7) days of the award of the bid written. Bids shall be received at the Village office, 113 East Railroad Street, West Lafayette, Ohio, until 4:00 p.m. on the ~~30th day of publication~~ AUG. 11TH 2017. Bids received after the final date and time will be rejected.
