A RESOLUTION TO ADOPT THE REMAINING YEAR 2018 BASE PAY & BENEFIT ALLOCATION FOR THE EMPLOYEES OF THE VILLAGE OF WEST LAFAYETTE, OHIO, AND TO REPEAL ORDINANCES AND RESOLUTIONS IN CONFLICT THEREWITH

BE IT RESOLVED by the Council of the Village of West Lafayette, State of Ohio, as follows

SECTION I: In order to compensate the employees of the Village of West Lafayette, State of Ohio properly, it is necessary to establish the fund allocation for the employees of the Village of West Lafayette, State of Ohio, in order to have satisfactory allocations for calendar year 2018, as well as a basis for 2019 appropriations.

SECTION II: That the fund allocation of wages of the following Village Employees effective immediately shall be and herewith are established as follows:


