Department Reports:

Fire: See attached report

Fiscal Officer: Fiscal Officer, Amy Bourne was absent and at training in Sandusky, Ohio all week. Payroll was completed prior to her leaving. Christie Maurer filled in taking minutes.

Police: See attached report. Movie night was cancelled due to the rain and was announced on WTNS. The new cruiser is waiting on the new antenna before putting it on the road.

Solicitor: Solicitor, Brett Hillyer, suggested that there be a hold on the passage or only do a first reading on Resolution 2018-33 so that he can look at the law regarding barred notices. All proposed resolutions and ordinances looked good.

Village Administrator: Village Administrator, Heather Stoffer made a request for a Public Works committee meeting to discuss water and sewer rates. The 4 new Burt Park closed signs have been posted. She will be sending letters out on June 12, 2018, at the request of the Buildings and Properties committee, to residents who made no effort to abate their violation. They will have 10 days to comply before they will be cited. She had a company assess a few trees that are of concern in the village due to large branches falling off the dead trees and is waiting on a quote. The final drawings for the Johnson Street sewer project should be complete this week. She will be

attending the school board meeting on Friday, June 15, 2018 to explain the basics of the project to them.

Committee Reports:

Building and Property: Chairman Tim Cheney reported that they met on May 30, 2018 and discussed properties that will be receiving letters this week.

Community & Business Development: Chairman Bo Fortune reported that they met on June 5, 2018 and discussed the Farmers Market. They will schedule another meeting to discuss further.

Community Relations: Chairman Tim Cheney reported that the Chamber of Commerce is having an emergency meeting that evening, June 11, 2018 and are still working on the homecoming. The next Chamber of Commerce meeting will be June 26, 2018. On June 23, 2018 from 10am-1pm there will be a food drive to raise money for the fireworks and another one on July 7, 2018 from 10am-1pm if they have not yet met their goal of \$5,000. There is a little over \$800 in the account now. Solicitor Brett Hillyer made a commitment to donate \$200 towards the fireworks.
