#### **Department Reports:**

**Fiscal Officer:** Fiscal Officer, Amy Bourne reported attending the Ohio Municipal League and Municipal Finance Officers annual conferences. Bills and October month end reports have been passed around for review and approval.

**Police**: See Attached. Police Chief Klopfenstein thanked everyone that supported and voted in favor of the police levy. Chief reported receiving a donation from the Lion's club for 2 vests to cover the 50% not covered by the bullet-proof vest program. Chief also presented a video on the new body cameras being used and the capability of residents sending information/evidence electronically to the department via the Axon Citizen component.

Solicitor: No Report.

Village Administrator: Village Administrator, Heather Stoffer, reported the Johnson Street Sewer project has been delayed due to the weather. A call is scheduled for later in the week to discuss dropping off supplies. Kirk Street parking has changed. Leaf pick up is in progress. Complaints have been received regarding leaves not being picked up. There are only 2 street workers to complete this as well as several other items on the work list, but it is being addressed. Christmas decorations will be going up within the next couple of weeks. A village Christmas party for the village employees was discussed. There is a Christmas decoration challenge for both residents and businesses. Registration forms due by November 30, 2018 and judging will be held December 22, 2018. Mayor Bordenkircher inquired about trees being cut down on Union that are laying in the street. Heather will reach out to the resident. Mayor inquired about 2 mobile homes being tore down and a timeline of when will be completed. The one on Main Street should be done by Friday. Mayor inquired about a small tree being cut down on the corner of Oak and Main Street. Mayor inquired about parking issues on S. Kirk St. The Police Chief proposed setting up a parking bureau.

**Public Works:** Chairman, Rich Wheeler, reported meeting on November 25, 2018 and discussed vacating the alley on the north side of town. The committee agreed as long as there is still access to the man-hole. The Village Solicitor stated that the landowners need to have it surveyed at their expense, then approved by the County. No public hearing necessary. An ordinance will need to be passed by council. Mosquito spraying was discussed and the committee feels we need to buy our own equipment and license our people. The Village Administrator is looking into pricing and it will be discussed again at the next meeting.
