A RESOLUTION TO AUTHORIZE AND DIRECT THE MAYOR TO ADVERTISE FOR BIDS FOR SALE OF A VEHICLE, BACKHOE AND ROLLER

Whereas Council for the Village of West Lafayette, Ohio is desirous of selling a used 1997 Ford F350 Squad, a 1987 Massey Ferguson Backhoe and a Beuthling Roller B-50, now therefore it is resolved:

Whereas Council has reviewed the petition in open meeting and intends to make a decision; Now therefore be it Resolved as follows:

<u>Section One:</u> Council for the Village of West Lafayette, Ohio declares that it is the owner of motor vehicles known as a 1997 Ford F350 Squad, a 1987 Massey Ferguson Backhoe and a Beuthling Roller B-50 and that it is no longer needed for public use.

<u>Section Two:</u> Council for the Village of West Lafayette, Ohio authorizes and directs the Mayor to advertise for invitation of bids for sale of the used motor vehicle:

- 1. 1997 Ford F350 Squad, 1FDK37F6VEC39707
- 2. 1987 Massey Ferguson Backhoe 50H A2088
- 3. Beuthling Roller B-50

Section Three: Specification for the invitation to bid and newspaper publication is attached as Exhibit "1" and is incorporated herein as though fully rewritten. The estimated value exceeds One Thousand and 00/100 Dollars (\$1,000.00) and a minimum bid for the 1997 Ford F350 shall be required of no less than Three Thousand and 00/100 Dollars (\$3,000.00) and a minimum bid for the Backhoe shall be required of no less than One Hundred and 00/100 Dollars (\$100.00) and a minimum bid for the Roller shall be required of no less than One Thousand and 00/100 Dollars (\$1,000.00). As per Ohio revised code Section 721.15 (a) the advertisement shall be published for not less than two (2) consecutive weeks in a local newspaper of general publication. The Village shall reserve the right to reject any and all bids and the bid for sale if awarded, shall be awarded to the highest and best bidder.

Section Four: That this Resolution shall be declared an emergency for necessity of health, safety and welfare of the citizens of West Lafayette, Ohio and shall be effective upon passage and signing by the Mayor.

The SEALED bids shall be accompanied by a ten (10%) percent certified bank check downpayment which shall be returned to unsuccessful bidders. The Village reserves the right to reject any or all bids.
