A RESOLUTION DECLARING CERTAIN VILLAGE PROPERTY NO LONGER NEEDED FOR MUNICIPAL PURPOSES AS SURPLUS AND OBSOLETE AND AUTHORIZING DISPOSAL OF SAID SURPLUS AND OBSOLETE PROPERTY

WHEREAS, the Village of West Lafayette is in possession of a vehicle assigned to the Village Police Department that has been taken out of service due to the need for costly repair and maintenance; and

WHEREAS, the out-of-service police vehicle is no longer needed for municipal purposes; and

WHEREAS, the Coshocton County Career Center, located at 23640 Airport Road, Coshocton, Ohio, is a vocational school offering a Criminal Justice program, among other programs; and

WHEREAS the Criminal Justice program prepares students for police officer and other criminal justice careers; and

WHEREAS, the Ridgewood Local School District, located in West Lafayette, Ohio, is one of the members of the Coshocton County Career Center, and thereby the students of the Ridgewood Local School District, which include residents of the Village of West Lafayette, are benefited by the Coshocton County Career Center programs; and

WHEREAS, Ohio Revised Code Section 721.15(C) provides that "[i]f the legislative authority of the municipal corporation determines that municipal property is not needed for public use, or is obsolete or unfit for the use for which it was acquired, and that the property has no value, the legislative authority may discard or salvage that property:" and

WHEREAS, the Village of West Lafayette has determined that the out-of-service police vehicle is municipal personal property that is not needed for public use and is obsolete or unfit for the use for which it was acquired, and that the property has no value, and therefore it is appropriate for the legislative authority to discard or salvage that property; and

WHEREAS, the out-of-service police vehicle could be used by the Coshocton County Career Center for its Criminal Justice program.

NOW, THEREFORE, BE IT RESOLVED by the Council of West Lafayette, Ohio that:

SECTION 1. Consistent with the provisions of the Ohio Revised Code, Section 721.15 and any applicable codified ordinances, the following equipment is declared surplus, no longer needed for municipal purposes, obsolete, and of no value, and authorization is hereby provided to dispose of the following property:

SECTION 2. Title to the property that is the subject of this Resolution shall be assigned to the Coshocton County Career Center or its designee, the property shall be received in "as-is" condition with no warranties or representations, and the Mayor and/or Fiscal Officer of the Village is hereby authorized to endorse the motor vehicle title accordingly.

SECTION 3. It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were adopted in an open meeting of this Council and that all deliberations of this Council and of any of its Committees that resulted in such formal action were in meetings open to the public and in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.

SECTION 4. That this Resolution shall be in full force and effect immediately upon its passage.

SECTION 5. That a copy of this Resolution shall be entered into the Official Records of the Village of West Lafayette, Ohio.
