A RESOLUTION AUTHORIZING THE VILLAGE ADMINISTRATOR TO MAKE A TEMPORARY APPOINTMENT OF PERSONNEL AND AUTHORIZING THE FISCAL OFFICER TO ADJUST PAY ALLOCATIONS RELATIVE TO THIS TEMPORARY APPOINTMENT, AND DECLARING AN EMERGENCY

WHEREAS, Section 735.273 of the Ohio Revised Code and Section 31.101 of the Ohio Basic Code, provide that the Village Administrator shall have such powers and duties as are prescribed by the laws of the State of Ohio and the Ordinances of the Village of West Lafayette; and

WHEREAS, the Village Administrator has determined that it is necessary for the efficient operation of the Village in conjunction with the Coshocton Water Project to temporarily create the position of Water Technician; and

WHEREAS, this position shall work with the contractor(s) involved in Contract B and C of the Coshocton Water Project with an adjusted and fluent work schedule, call back responsibility, extended work hours, and adjusted rate of pay; and

WHEREAS, this position will exist for the length of time determined by the Village administrator. At which time the position is no longer needed, the individual appointed as the Water Technician will resume their previous job title and duties at its corresponding wage.

NOW, THEREFORE, BE IT ORDAINED as follows by the Council for the Village of West Lafayette, Ohio:

SECTION I: Council does hereby approve granting the authority to the Village Administrator to appoint a Water Technician that shall receive all of the pay and benefits as a full time, non-exempt employee as outlined in Ordinance 2020-41.

SECTION II: Council does hereby approve the Fiscal Officer to compensate the Water Technician at the rate of pay of \$15.76 per hour (the same as an Operator Tech) as established in Ordinance 2020-41. The pay allocation for the Water Technician shall be the same as that of the Laborer Class as listed in Resolution 2020-43 with exception of the 15% allocated from the water fund. Once the Water Technician exceeds 15% or six (6) hours of his regularly scheduled work hours, then each hour thereafter spent on activities associated with the Coshocton Water Project, as determined by the Village Administrator, shall be allocated from the water fund at 100%.

The Water Technician shall maintain and submit, with his timesheets, the allocation of time spent within each of funding sources above and the documentation shall be approved by the Village Administrator and submitted to the Fiscal Officer for processing and subsequent payment.


SECTION III: This Resolution shall be applicable on and after August 17, 2020.

SECTION IV: This Resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public health, safety, and welfare. The reason for such necessity is that the Coshocton Water Project is well underway, and the creation of this position is necessary to properly work with the contractors of the project in order to effectively maintain proper project progression, and the Resolution is necessary to provide full authority for the Fiscal Officer and Administrator to create the position of Water Technician. Therefore, this Resolution shall go into immediate effect upon passage.
