**A RESOLUTION AUTHORIZING THE VILLAGE OF WEST LAFAYETTE TO PREPARE AND SUBMIT AN APPLICATION TO PARTICIPATE IN THE ENVIRONMENTAL STEWARDSHIP PILLAR OF PROSPERITY FOUNDATION FOR APPALACHIAN OHIO GRANTS AND TO EXECUTE CONTRACTS AS REQUIRED AND DECLARING AN EMERGENCY.**

**Whereas**, the State of Ohio, through the Environmental Stewardship Pillar of Prosperity at the Foundation for Appalachian Ohio Grants, to provide funding opportunity for communities to enhance parks and greenspaces in such a way as to encourage members of the public to connect more to outdoor activities.

**Whereas**, the Village of West Lafayette desires financial assistance from the Environmental Stewardship Pillar of Prosperity at the Foundation for Appalachian Ohio Grants Program.

**NOW, THEREFORE**, be it resolved by the Council of the Village of West Lafayette, State of Ohio as follows:

**Section 1:** That the Village of West Lafayette approves filing an application for The Environmental Stewardship Pillar of Prosperity at the Foundation for Appalachian Ohio Grants Program.

**Section 2:** That the Village Administrator is hereby authorized and directed to execute and file an application with the Environmental Stewardship Pillar of Prosperity at the Foundation for Appalachian Ohio Grants Program and to provide all information and documentation required to become eligible for possible funding assistance.

**Section 3:** That the Village of West Lafayette does agree to obligate the funds required to satisfactorily complete the proposed project under the terms and conditions of the Environmental Stewardship Pillar of Prosperity at the Foundation for Appalachian Ohio Grants Program.

**Section 4:** That this resolution shall be and is hereby declared to be an emergency measure for the preservation of public peace, health, and safety for the Village of West Lafayette and its inhabitants by timely entering into the grant approval process meeting all necessary application and project submission deadlines and shall take effect and be in force immediately upon its passage and approval; otherwise it shall take effect and be in force and after the earliest period allowed by law.
