Fire: No report.

Fiscal Officer: Fiscal Officer, Amy Bourne reported that the 2020 Annual Financial report has been completed and submitted to the State Auditor and is available for review in the Administration office during business hours. Those wanting to view the report can call 740-545-6541 to make an appointment to review the report. The balance of the Water Fund was delivered to the City of Coshocton in early February. There is still money being receipted into the Water fund form existing water bills being paid and that money will be used to pay the Office Manager

wages as well as any outstanding invoices that come in relating to water until the project is completed. The loan papers have been signed for the Fire department rescue vehicle. The truck has been picked up and delivered to Jomac for the utility body work to be done. They will not be done with that work until around July due to their schedule filling up since we initiated the purchase process. The Police department Chevy truck has been delivered and will be dropped off to Parr for the upfit equipment to be installed next week. A \$10,000 check was received today from the Coshocton Foundation grant as well as a \$2,500 donation from Home Loan Savings bank putting the total K-9 donation up to over \$20,000 to date. There are still upcoming fundraisers that will also add money. A Resolution to add funds is needed to appropriate money to continue paying wages and bills out of the Water fund through project completion. \$1,000 is also needed to finish the K-9 vehicle and COVID fund bank interest received needs appropriated to be able to spend this year. Bills were passed around for approval.

Village Administrator: Chris Menapace requested a motion to accept the bids that were presented for the sale of the Village items. Chris and Mayor Bordenkircher created a video explaining the upcoming process for water shutoffs in the Village related to the Coshocton water project. The water will be shut off to 14 residents tomorrow due to nonpayment of water bills. On February 12, 2021, Jared Boone left the Village for other employment and Nathan Gress has been hired to replace him. Gress will start on March 1, 2021 and plans to obtain his Class I Wastewater license. The bids for the restroom project at Waterworks park are due to the office by Friday, February 25, 2021. There have been 4 new portable 4-way stop signs with flashing lights placed at the intersection of Kirk and Main until the traffic light has been replaced.
