A RESOLUTION TO ADOPT THE BASE PAY & BENEFIT ALLOCATION FOR THE EMPLOYEES OF THE VILLAGE OF WEST LAFAYETTE, OHIO AND TO REPEAL ORDINANCES AND RESOLUTIONS IN CONFLICT THEREWITH

BE IT RESOLVED by the Council of the Village of West Lafayette, Coshocton County, Ohio, as follows:

SECTION I: In order to compensate the employees of the Village of West Lafayette, State of Ohio properly, it is necessary to establish the fund allocation for the employees of the Village of West Lafayette, State of Ohio.




