Fiscal Officer: Fiscal Officer, Amy Bourne reported Ordinance 2021-53 for the 2021 Pay & Benefit schedule is on the table to update wording throughout that relates to the Police Department changing back to an 8-hour work schedule from a 12-hour schedule. Resolution 2021-55 is needed to add funds to the General Fund in the amount of \$5,700 to replenish the Police Department uniform account with money received from a bullet proof vest grant received. Money is also needed in the General Fund to cover the Solicitor fees for the remainder of 2021 as well as \$12,000 into the Fire fund to cover the installation of the emergency lights in the new rescue truck. Resolution 2021-58 is needed to authorize the Fire Chief and Fiscal Officer to sign paperwork for the purchase of a new fire truck in the amount of \$690,833 on a 15-year lease. The July month end cash summary was presented to the Finance committee this evening and the bills were passed around for approval.

I think it is incumbent upon elected leaders to provide the citizenship with a candid and clear statement of the functions of the government to the extent allowable by law. Historically, the media has been helpful in both holding the government accountable and providing a method to deliver that information to the public.

As we all know a lot of that has changed over the years. Most people get their news from social media which often editorializes more than simply providing the information. Information from those sources are used for other sources, which also add their own spin and opinion. The stories we read are often retellings of retellings of someone else's opinion and what catches the eye is not the most accurate representation of the event but rather the hottest take or the most liked version. And so, a society's own feelings about the story drive the narrative of what version of the story is most commonly known, not accuracy.

I am aware of concerns many residents have about Chief Fohl and Officer Mans. I have been intimately involved in both of their careers at West Lafayette, as well the circumstances surrounding the conclusion of their time here. I expect both Matt Fohl and Laurice Mans will go on to continue their careers in law enforcement elsewhere, but that is in-part my own speculation.

Chief Fohl resigned on August 13, 2021. At the time of his resignation, I was engaged in an investigation of certain circumstances, which included Officer Mans and K-9 Officer Stryder. That investigation has not concluded and so on advice of Counsel, I am not at liberty to say anything beyond that. While I cannot stop others from speculating about that investigation, I will state that Chief Fohl has resigned after serving West Lafayette for14 months, his resignation was done professionally and with integrity. And such false speculation can cause real damage to a person's life.

I am also aware of how important the K-9 program has been to the village. That program has very strict requirements. Failing to follow those requirements would render the hard work of Officer Mans and K-9 Stryder meaningless. While I was investigating alleged shortcomings with some of those requirements at the time of Chief Fohl's dismissal, it was the village's intention to work with Officer Mans to ensure all the requirements were fulfilled.

For reasons unrelated to the K-9 requirements, Officer Mans and the Village of West Lafayette have separated their employment relationship and while I cannot provide any additional detail at this time, I would caution anyone against spreading rumor or slander against Officer Mans.

There is a very real person that wore that uniform, trained with K-9 Stryder, and served the village of West Lafayette — a person with their own challenges, worries, and uncertainties. Like anyone else, he deserves to continue his career elsewhere and close this chapter of his life in West Lafayette.

On or about July 19, 2021, acting on information regarding the police department an investigation was started. The investigation remains open, as a result a it is not subject to a public records request for legal and ethical reasons.

To dispel several rumors: 1.) The rumor regarding the theft of money is untrue. While a budget shortfall has been addressed following Chief Fohl's departure, at no time during that process or the investigation was there any evidence to suggest a theft in office had occurred. The budget shortfall has been addressed, and the budget is back on track. 2.) At no time, were any concerns regarding sexual harassment or discrimination of our female officers raised. 3.) The canine program has been suspended

due to shortcomings with the canine protocol and or policy. I know this is an very important program to the Village of West Lafayette, which is why strict compliance with those protocols and policy are required. It was the intention of the Village to work with Office Mans to address those shortcomings at the time of his professional separation for unrelated reasons. The canine program remains under evaluation.

#### August 23, 2021

- 1. ODOT has completed their study of the intersection for the corner of Main and Kirk. We have been given permission to make the intersection a permanent 4 way stop. Since this change in the intersection, if approved, was going to be included in the SR 93 paving project that was postponed until next year, ODOT is still going to pay for changing the intersection including:
  - a. Removing and discarding all existing overhead equipment and wires
  - b. Supply and installation of 4-30" in diameter stop signs.

After the installation of the new signs, the Village will mount the blinking red lights on top of each of the newly installed stop signs, This work is scheduled to occur at some point in the next two weeks.

- 2. We have taken inventory of the pools in the Village that do not comply with our ordinances regarding fencing. Each residence that is in violation with the ordinance will be receiving a copy of our "Safe Swimming at Home Initiative" and letter from the VA explaining what will need to occur to bring their property into compliance. These letters will be mailed out towards the end of this week.
- 3. We will find out if we received our CBDG and NRG grants by the end of this week.
- 4. Round 36 Paving requests are due next week, so we will be deciding on what streets to add to the paving list later this week. We need to verify whether or not we receive the NRG prior to determining which streets will be chosen to pave next year as some of the NRG components involve street paving.
- 5. Our Wastewater Plant Outfall Upgrade project was ranked #2 of the 14 submitted projects within our County and we have submitted the project to the Ohio Department of Development. The overall cost of the project is 3.38 million dollars and we will have less than \$15,000 in local funding if the grants that we applied for fall into place. I will provide more details of the project should it be chosen to be funded by the ODOD.
- 6. LEGISLATION:
  - a. 2021-52, just needs a second reading
  - b. 2021-53, please consider waiving the rules and take this to its third and final reading. The Fiscal Officer likely highlighted all of the changes that needed to be made relative to benefit hours for police department personnel. Items involving my personnel are
    - i. Removing the old title of Operator III and replacing it with Operator of Record
    - ii. Updating any reference to Operator III to reflect the new title of Operator of Record
    - iii. Changing the wording of sick time usage and when supervisors may require a doctor's excuse
    - iv. Updating the job classification descriptions in the appendix removing any reference to water department
  - c. 2021-56, first reading......please make sure that if you interested in purchasing one of the vehicles, you properly submit a sealed bid as described in Exhibit A of the ordinance
  - d. 2021-57, first reading.....will eliminate the need to waive this rule each time someone is hired. The ordinance is no longer person specific, it is position specific
