A RESOLUTION TO AUTHORIZE AND DIRECT THE VILLAGE ADMINISTRATOR TO ADVERTISE FOR BIDS TO SELL TWO PASSENGER VEHICLES AND A STREET SWEEPER.

WHEREAS, Council for the Village of West Lafayette, Ohio desires to sell a used 1998 Pelican Street Sweeper, a 2005 Honda Accord, and a 2011 Ford Crown Victoria; and

WHEREAS, Council for the Village of West Lafayette, Ohio desires to sell two passenger vehicles. The first, a 2005 Honda Accord, in which the village obtained ownership through a drug seizure operation. The second is the former K-9 Cruiser, a 2011 Ford Crown Victoria; and

WHEREAS, Council for the Village of West Lafayette, Ohio declares that it is the owner of the 1998 Pelican Street Sweeper, the 2011 Ford Crown Victoria, and the 2005 Honda Accord and that the vehicles are no longer needed for public use; and

WHEREAS, Council has reviewed the request by the Village Administrator in open meeting and intends to make a decision.

**NOW THEREFORE, BE IT RESOLVED,** that the Council for the Village of West Lafayette Ohio, authorizes and directs the Village Administrator to advertise for the invitation of bids for sale of the 1998 Pelican Street Sweeper, the 2011 Ford Crown Victoria, and the 2005 Honda Accord as specified below:

Section 1: Specification for the invitation to bid and the newspaper publication is attached as "Exhibit A" and is incorporated herein as though fully rewritten. The estimated value of the 2005 Honda Accord is approximately Five Hundred dollars (\$500.00). Therefore, a minimum bid of Five hundred dollars (\$500.00), will be required in order for the Honda Accord to be purchased. The estimated value of the 2011 Ford Crown Victoria is Five Hundred Dollars (\$500.00). Therefore, a minimum bid of Five Hundred dollars, (\$500.00), will be required in order for the Ford Crown Victoria to be purchased. The estimated value of the 1998 Pelican Street Sweeper is Seven Thousand Five Hundred Dollars (\$7,500.00). Therefore, a minimum bid of Seven Thousand Five Hundred Dollars (\$7500.00) will be required in order for the vehicle to be purchased. As per Ohio revised code Section 721.15 (a) the advertisement shall be published for not less than two (2) consecutive weeks in a local newspaper of general publication. The Village shall reserve the right to reject any and all bids and the bid for sale if awarded, shall be awarded to the highest and best bidder.

Section 2: That this Resolution shall be declared an emergency for necessity of health, safety and welfare of the citizens of West Lafayette, Ohio for the reasons that the sale of these items can best be facilitated as soon as possible as the Village wishes to remove the vehicles from its fleet and off of its property and shall be effective upon passage and signing by the Mayor.
