Department Reports:

Fire: No report.

Fiscal Officer: Fiscal Officer, Amy Bourne reported Ordinance 2022-04 will receive its first reading to adopt the 2022 version of the Ohio Basic Code. Changes were made to add the new 2021-65 Building and Zoning codes ordinance that was passed in late 2021 as well as Ordinance 2022-07 establishing parking violation penalties that is receiving its second reading. Resolution 2022-10 is needed to authorize the Mayor and/or Village Administrator to apply for an EPA loan to cover the Village portion of the sewer outfall project and will be submitted by Erin with the Thrasher Group. The amount of the loan is unknown yet as Erin is working on other grant funding to help offset the Village share. Bourne registered and will be attending an Ohio Association of Public Treasurers conference in June. Bills were passed around for approval.

Police: No report.

Solicitor: Village Solicitor, Joel Blue, had nothing to report.

Village Administrator: Village Administrator Tammy Hicks reported that the Main St. sewer project should begin in June and will run for 3-4 months. ODOT feels that they will be able to hold off on their paving project of SR 93 through the Village so Main St. doesn't get torn up from the sewer project right after being newly paved. The sewer project on Indian Circle has

been put out to bid and will be in the Beacon and Tribune for 2 weeks starting this week. Easements should be going out to homeowners affected soon. The project is expected to begin in April and last roughly 3-4 weeks. The Mayor was contacted regarding the sewer outfall project with recommendations of routing the project a different way, but after meeting with the Village Administrator, Ryan Cottrell and Nate Gress and walking the project it was determined that the rerouting could potentially cause much flooding for area farmers as well as significant maintenance with dredging along creek beds. The plan is to stay with the original plans for routing directly to the river. Quotes are being obtained for roof and interior repairs for the street department building. The building has a rotten facia board along the west side that is allowing water to run inside down the walls and causing damage. Two quotes have been received and waiting on one more quote before making a decision. Potholes were patched last week and 2.5 tons of cold mix was used. More cold patch is being purchased this week to finish filling holes that were missed. New street signs were received from a Lafayette township grant and will be scheduled to be installed soon. Electricians installed new LED bulbs in the 3 of the 5 light poles at Burt Park. A Public Works committee meeting was requested to discuss personnel matters and conducting a smoke test in the Village. A smoke test will push smoke into the sewer lines and look for residents that have their spouting hooked up to the sanitary sewer lines where they should not be, which according to the EPA, is not allowed. There will be notices put out to residents once it is scheduled as there is the potential for homes to fill with smoke if there is not water in their traps. Mayor Bordenkircher reported finding out about a grant possibility for flood lands and has asked VA Tammy and our engineers to look into the project. If awarded the grant, the Village could possibly extend storm sewers down Oak St. to 7th St as well as down Wall St. to 5th St., which are both areas that were impacted by the flood in 2019.

The 2022 Homecoming will be held on July 28-30, 2022 with Mike Masloski being the Grand Marshall. The eat and will be getting new rolling garage doors. Albany's amusements will provide the entertainment for the Homecoming. The Christmas parade will be held on December 3, 2022 at 12:30 PM, rather than 1:00PM. The Chamber requested that the Village store their Christmas decorations for Main St. as they are running out of room.
