A RESOLUTION TO AUTHORIZE AND DIRECT THE VILLAGE ADMINISTRATOR TO ADVERTISE FOR BIDS TO SELL A 1986 PIERCE MINI PUMPER.

WHEREAS, Council for the Village of West Lafayette, Ohio desires to sell a used **1986 Pierce Mini Pumper**.

WHEREAS, Council for the Village of West Lafayette, Ohio declares that it is the owner of the **1986 Pierce Mini Pumper**, and that the vehicle is no longer needed for public use.

WHEREAS, Council has reviewed the request by the Village Administrator in open meeting and intends to make a decision.

NOW THEREFORE, BE IT RESOLVED, that the Council for the Village of West Lafayette Ohio, authorizes and directs the Village Administrator to advertise for the invitation of bids for sale of the **1986 Pierce Mini Pumper** as specified below:

Section 1: Specification for the invitation to bid and the newspaper publication is attached as "Exhibit A" and is incorporated herein as though fully rewritten. The estimated value of the **1986 Pierce Mini Pumper** is Five Thousand Dollars, (\$5,000.00). Therefore, a minimum bid of Five Thousand Dollars, (\$5,000.00), will be required in order for the vehicle to be purchased.

As per Ohio revised code Section 721.15 (a) the advertisement shall be published for not less than two (2) consecutive weeks in a local newspaper of general publication. The Village shall reserve the right to reject any and all bids and the bid for sale if awarded, shall be awarded to the highest and best bidder.

Section 2: That this Resolution shall be declared an emergency for necessity of health, safety and welfare of the citizens of West Lafayette, Ohio for the reasons that the sale of these items can best be facilitated as soon as possible as the Village wishes to remove the vehicles from its fleet and off of its property and shall be effective upon passage and signing by the Mayor.



Newspaper Advertisement

Pursuant to Resolution #2022-65, the Village of West Lafayette, Ohio is offering for sale to the highest and best bidder the following items:


1. **1986 Pierce Mini Pumper**

- 27,886 miles
- VIN# 1FDXF3817GP852408
- Ford F350 chassis
- 400 GPM pump
- 250 gallons of water
- The estimated value of the Pierce Mini Pumper is Five Thousand Dollars, (\$5,000.00)
- Therefore, a minimum bid of Five Thousand Dollars, (\$5,000.00), will be required in order for the vehicle to be purchased.
- The vehicle is being sold as is, where is, and without warranty. The successful bidder shall be responsible for delivery.

The vehicle may be viewed at the Village of West Lafayette Administration Building located at 113 East Railroad Street, West Lafayette Monday-Thursday between 8:00 AM and 3:00 PM.

The SEALED bid shall be accompanied by a certified bank check or money order of Ten Percent (10%) of the amount of bid which shall be returned to unsuccessful bidders. The Village reserves the right to reject any or all bids. The successful bidder shall pay to the Village the remaining amount due by certified bank check or money order and shall take possession of the purchased item and remove it, within thirty (30) days of award of the bid. Bids will be opened November 28, 2022, during the regularly scheduled Village Council Meeting which commences at 7:00 pm and the purchase and sale or rejection of any or all bids shall be announced. A contract of sale shall be executed within seven (7) days of the award of the bid written. **SEALED** bids shall be received at the Village Administration Office, 113 East Railroad Street, West Lafayette, Ohio, until 12:00 p.m. on Friday, November 18, 2022. Bids received after the final date and time will be rejected.
