Executive Session:

A motion was made at 7:02pm by Bo Fortune and seconded by Ron Lusk to go into executive session to discuss litigation with the Fiscal Officer and Village Administrator to remain. Roll call 6 yes.

A motion was made at 7:08pm by Bo Fortune and seconded by Tim Cheney to continue in open session. Roll call 6 yes.

Department Reports:

Fire: No report.

Fiscal Officer: Fiscal Officer, Amy Bourne, reported on the legislation being presented. Ordinance 2022-49 will receive its third and final reading for a 6% increase in sewer rates in the Village. The ordinance also contains the recently increased water rates for the City of Coshocton. Resolution 2022-50 will receive its second reading to accept the amounts and rates from the County budget commission and requested to waive the third and final reading due to the deadline to submit the certification to the Auditors office. Amounts expected for the General Fund that are inside the 10-mil limit are \$52,976 and for the General Fund and Police Levy Fund that are outside the 10mill limit are \$66,754 and \$45,860 respectively. Ordinance 2022-51 will receive its second reading authorizing the Mayor, Fiscal Officer and Fire Chief to sign the 2023 fire contracts with the Townships. Resolution 2022-58 will authorize the Mayor and Fiscal Officer to apply for an ARC grant to help offset the engineering costs for the sewer outfall project. Resolution 2022-60 is needed to add funds in the amount of \$10,000 in the Sewer fund for emergency repairs to a sewer line near the alley on Center St. between Main and Russell Ave.

Bourne will be out of the office attending an Ohio Association of Public Treasurer's conference next week. Bills were passed around for approval.

Solicitor: Village Solicitor, Joel Blue, had nothing to report.

Village Administrator: Village Administrator Tammy Hicks reported that the sidewalk project on Russell has started with the trees being removed last week and the sidewalk removal will begin this week. Only one estimate has been received so far for the alley paving between Main and Russell. Grason Construction has completed the new sanitary lateral work at 401 W. 5th St last week. Crosswalk painting was completed today. An emergency repair is needed to a sanitary sewer line that is cracked and a process called Pipe-lining will be used to repair. William Albert's will be doing the repair. Hicks read a letter from Hannah Diewald from CDC with an update on the Critical Infrastructure grant and Neighborhood Revitalization grant. There were issues with the original construction plan and changes have been made moving to Phase 2 of the project, providing storm sewers to an unserved area of the Village. The original bids received for Phase 2 were well over budget. The scope of the project was reduced and the project will be rebid this winter. Mayor Bordenkircher reported that the deed for the Wetlands has been received and the Resolution approving the acquisition of that land will receive its first reading. He inquired about estimates for the sewer project at Ripple and Main. Hicks stated that no quotes have been received yet.
